AN ORDINANCE ADOPTING THE "CODE OF ORDINANCES OF THE CITY OF DAVIS CITY, IOWA"

BE IT ORDAINED by the City Council of the City of Davis City, Iowa, that:

SECTION 2. All of the provisions of the "CODE OF ORDINANCES OF THE CITY OF DAVIS CITY, IOWA," shall be in force and effect on and after the effective date of this ordinance.

SECTION 3. All ordinances or parts thereof in force on the effective date of this ordinance are hereby repealed from and after the effective date of this ordinance, except as hereinafter provided.

SECTION 4. The repeal provided for in the preceding section of this ordinance shall not affect any offense or act committed or done or any penalty or forfeiture incurred or any contract or right established or accruing before the effective date of this ordinance; nor shall such repeal affect any ordinance or resolution promising or guaranteeing the payment of money by the City or authorizing the issuance of any bonds of said City or any evidence of said City's indebtedness or any contract or obligation assumed by said City; nor shall said repeal affect the administrative ordinances or resolutions of the Council not in conflict or inconsistent with the provisions of "THE CODE OF ORDINANCES OF THE CITY OF DAVIS CITY, IOWA"; nor shall it affect the following ordinances specifically saved from repeal:

nor shall it affect any other right or franchise conferred by any ordinance or resolution of the Council or any other person or corporation; nor shall it affect any ordinance naming, establishing, relocating or vacating any street or public way, whether temporary or permanent; nor shall it affect any ordinance amending the official zoning map, establishing building lines, establishing and changing grades, or dedicating property for public use; nor shall it affect any prosecution, suit or ordinance.

SECTION 6. An official copy of the "CODE OF ORDINANCES OF THE CITY OF DAVIS CITY, IOWA," adopted by this ordinance, including a certificate of the City Clerk as to its

adoption and the effective date, is on file in the office of the City Clerk, and shall be kept available for public inspection.

SECTION 7. The City Clerk shall furnish a copy of the "CODE OF ORDINANCES OF THE CITY OF DAVIS CITY, IOWA," to the Judicial Magistrates serving the City of Davis City.

SECTION 8. This ordinance shall be in full force and effect from and after the publication of this ordinance, as required by law.
