

ORDINANCE NO. 1128

AN ORDINANCE AMENDING THE CLIVE CITY CODE 2019, BY AMENDING  
PROVISIONS PERTAINING TO CASH CONTROL PROCEDURES

Be It Enacted by the City Council of the City of Clive, Iowa:

SECTION 1. INTERNAL REFERENCES. All references to section numbers in this ordinance shall be to sections contained within Title 3, Chapter 1, Section 3 (Cash Control) of the "Clive City Code 2019" unless otherwise specified.

SECTION 2. AMENDMENT. Section 3-1-3 (Cash Control) Subsection D(1) referencing Change Funds is hereby amended and substituted in lieu the following:


1. Finance Officer: The Finance Officer is authorized to draw a check on the Utilities Fund for establishing a Change Fund in the amount of two hundred dollars (\$200.00) for the purpose of making change without commingling other funds to meet the requirements of the Utility Billing Department. The Finance Officer is further authorized to draw a check on the General Fund for establishing a Change Fund in the amount of two hundred dollars (\$200.00) for the purpose of making change without commingling funds to meet the requirements of the Administrative Services Department. Said Change Funds shall be in the custody of the Finance Officer, who shall maintain the integrity of the fund.


SECTION 3. REPEALER. All parts of the "CLIVE CITY CODE 2019" in conflict herewith are hereby repealed.

SECTION 4. SEVERABILITY CLAUSE. If any section, provision, sentence, clause, phrase or part of this Ordinance shall be adjudged to be invalid or unconstitutional, such adjudication shall not affect the validity of this Ordinance as a whole or any section, subsection, provision, sentence, clause, phrase or part thereof not adjudged invalid or unconstitutional.


SECTION 5. WHEN EFFECTIVE. This Ordinance shall be in effect from and after its final passage, approval and notice of its passage is given as provided by law.




