ORDINANCE NO. 113

AN ORDINANCE AMENDING THE CLIVE CITY CODE 2019, BY AMENDING PROVISIONS PERTAINING TO WATER RATES

Be It Enacted by the City Council of the City of Clive, Iowa:

SECTION 1. <u>INTERNAL REFERENCES.</u> All references to section numbers in this ordinance shall be to sections contained within Title 8, Chapter 1, Article B (Water Rates) of the "Clive City Code 2019" unless otherwise specified.

SECTION 2. <u>AMENDMENT</u>. Section 8-1B-2 is hereby deleted in its entirety and the following new Section 8-1B-2 is inserted in lieu thereof:

8-1B-2: RATES FOR SERVICE. Effective May 15, 2023, water service shall be furnished at the following rates within the city:

(Code of Iowa, Sec. 384.84)

- A. General Rate: Except as otherwise provided herein, water use shall be billed at the following general rate: Eight dollars and forty-eight cents (\$8.48) per one thousand (1,000) gallons used, prorated to the nearest 100 gallons, billed monthly.
- B. Irrigation Meter Rate: For water use registered by an irrigation meter, for which no sewer service charge is made, the following rate applies and not the general rate:
 - 1. Residential Customers: Irrigation water use shall be billed at a rate of 1,000 gallons, prorated to the nearest 100 gallons, as specified in the following tiered rate chart:

1 - 10,000 gallons	\$8.48
10,001 to 30,000 gallons	\$9.75
30,001 + gallons	\$12.72

2. Commercial Customers: Irrigation water use shall be billed at a rate of 1,000 gallons, prorated to the nearest 100 gallons, as specified in the following tiered rate chart:

0-200,000 gallons	\$10.11
200,001 + gallons	\$14.16

SECTION 3. <u>REPEALER</u>. All parts of the "CLIVE CITY CODE 2019" in conflict herewith are hereby repealed.

SECTION 4. <u>SEVERABILITY CLAUSE</u>. If any section, provision, sentence, clause, phrase or part of this Ordinance shall be adjudged to be invalid or unconstitutional, such adjudication shall not affect the validity of this Ordinance as a whole or any section, subsection, provision, sentence, clause, phrase or part thereof not adjudged invalid or unconstitutional.

SECTION 5. <u>WHEN EFFECTIVE</u>. This Ordinance shall be in effect from and after its final passage, approval and notice of its passage is given as provided by law.
