

ORDINANCE NO. 1132

AN ORDINANCE AMENDING THE CLIVE CITY CODE, 2019, BY AMENDING PROVISIONS PERTAINING TO SANITARY SEWER SERVICE RATES AND CONNECTION CHARGES

Be It Enacted by the City Council of the City of Clive, Iowa:

SECTION 1. INTERNAL REFERENCES. All references to section numbers in this ordinance shall be to sections contained within Title 8, Chapter 2, Article D, entitled Sanitary Sewer System-Service Rates and Connection Charges of the Clive City Code, 2019, unless otherwise specified.

SECTION 2. AMENDMENT. Section 8-2D-2(A) is hereby deleted in its entirety and the following new Section 8-2D-2(A) is inserted in lieu thereof:

**8-2D-2: BASIC RATE:**

A. Except as hereinafter noted, effective May 15, 2023, each customer whose property lies within the corporate limits of the city shall pay to the city, through its collection agent, the Clive Water Department, at the same time payment for city water service is made, the following charges:

1. A flat sewer availability charge at the rate of eight dollars and forty-nine cents (\$8.49) per month, regardless of the amount of consumption by the customer; and


2. A sewage consumption charge computed on water consumption at the rate of six dollars and forty-seven cents (\$6.47) per one thousand (1,000) gallons of water used, prorated to the nearest 100 gallons, billed monthly.


SECTION 3. REPEALER. All parts of the "CLIVE CITY CODE, 2019" in conflict herewith are hereby repealed.

SECTION 4. SEVERABILITY CLAUSE. If any section, provision, sentence, clause, phrase or part of this Ordinance shall be adjudged to be invalid or unconstitutional, such adjudication shall not affect the validity of this Ordinance as a whole or any section, subsection, provision, sentence, clause, phrase or part thereof not adjudged invalid or unconstitutional.


SECTION 5. WHEN EFFECTIVE. This Ordinance shall be in effect from and after its final passage, approval, and notice of its passage is given as provided by law.
