Whereupon, the Mayor declared the motion duly carried and the ordinance duly adopted, as follows:

ORDINANCE NO. 1138

An Ordinance Repealing Ordinance No. 775 Providing for the Division of Taxes Levied on Taxable Property in the 128th Street Addition to the Clive Urban Renewal Area

WHEREAS, the City Council (the "Council") of Clive, Iowa (the "City") previously enacted Ordinance No. 775 (the "Ordinance") providing for the division of taxes levied on Taxable Property in the 128th Street Addition to the Clive Urban Renewal Area pursuant to Section 403.19 of the Code of Iowa; and

WHEREAS, it is now necessary for the Council to take action to repeal the Ordinance;

BE IT ENACTED by the City Council of the City of Clive, Iowa:

Section 1. Purpose. The Ordinance is hereby repealed as of July 1, 2024, and the City's ability to collect incremental property tax revenues (the "TIF Revenues") from the 128th Street Addition to the Urban Renewal Area is hereby terminated as of July 1, 2024. The City will continue to collect TIF Revenues from the 128th Street Addition to the Urban Renewal Area through the end of the City's 2023-2024 fiscal year.

Section 2. Repealer. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 3. Saving Clause. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

Section 4. Effective Date. This ordinance shall be effective after its final passage, approval and publication as provided by law.
